## Instructions for Submitting Abstracts

Abstracts providing an update on the results of each funded “Plan of Work” conducted in support of the Sclerotinia Initiative should be submitted by **Friday, December 18, 2009**. Abstracts will be compiled into a proceedings booklet and CD that will be distributed at the Annual Meeting. Multiple abstracts can be submitted for funded plans of work with more than one investigator.

Abstracts should be submitted electronically (via e-mail) as a Microsoft Word 6.0 (or higher version) document. Abstracts should be no longer than one page in length and should be single spaced using Times New Roman 12-point font. Left margins should be 1.5 inches and right margins 1 inch in width.

The following information should be included on each submitted abstract:

- Abstract title (bold print)
- Authors (name and institution)
- Name of funded plan of work the abstract supports
- Contact information for primary author
